Mesothelioma

Many manufacturers knew the dangers of asbestos exposure but put profits ahead of people and continued to put their workers in harm's way.

Although some companies are no longer in business, special court-ordered trusts — estimated at over \$30 Billion — have been set up to provide money for mesothelioma victims and their families.

Simmons Hanly Conroy brings claims against the manufacturers of asbestos-containing products, not the U.S. government or the military. Even if a loved one is deceased, a family member may be able to file a claim.

A rare and deadly cancer, mesothelioma is directly linked to asbestos exposure in mills, shipyards, or in the heating, construction, and automotive industries, as well as the military. Exposure through an occupation or while in the military decades ago may cause mesothelioma and other asbestosrelated diseases.



Zimmer Biomet Hip Replacement

Zimmer Biomet CPT® Hip System devices may increase the risk of femur fractures. A recall in July 2024 was prompted by concerns that the cobalt-chromium alloy implant is twice as likely to cause thigh bone fractures when compared to similar products made of stainless steel.



NEC Baby Formula

Cow's milk-based baby formula and milk fortifier products (like Enfamil™ and Similac®) can greatly increase the risk of premature and low-birth-weight babies developing a potentially fatal intestinal disease called necrotizing enterocolitis (NEC).



Tepezza®

Tepezza (or teprotumumab) is an injectable drug used to treat thyroid eye disease (TED). The use of Tepezza, however, has recently been linked to permanent hearing loss and/or tinnitus, a ringing in the ears.



Talcum Powder

Johnson & Johnson Baby Powder, Shower-to-Shower and other talc-based powder brands failed to include warnings on its products regarding the link between talcum powder and ovarian cancer.



Breast Implant Cancer

Allergan breast implants and tissue expanders have been linked to breast implant-associated anaplastic large-cell lymphoma (BIA-ALCL), a rare type of non-Hodgkin's lymphoma. Many women have experienced significant side effects associated with these recalled implants, undergoing invasive surgery, painful treatments and the uncertainty of a cancer diagnosis.

Chemical Hair Straightener/Relaxer

Women who used chemical hair straightening or relaxer products frequently (more than four times in the last year) may have twice the risk of developing uterine cancer compared to those who didn't use the products, according to a new study by the National Institutes of Health (NIH).



Social Media Addiction

Meta's Facebook and Instagram, Snapchat, YouTube, and TikTok face an onslaught of social media addiction lawsuits nationwide. Named Partner, Jayne Conroy, has been appointed to the Plaintiffs' Steering Committee Leadership in the *In re: Social Media Adolescent Addiction/Personal Injury Products Liability Litigation,* which alleges social media platforms encourage addictive behavior in adolescents. Thousands of pages of internal documents were leaked that show Facebook knew the harm it was causing — especially to its youngest users.



Roundup[®]

Roundup weed killer contains glyphosate, an herbicide that may be linked to non-Hodgkin's lymphoma and other serious illnesses. Those who develop cancer after being exposed to glyphosate, may be able to file a Roundup lawsuit for compensation.



Depo-Provera®

Patients taking Depo-Provera may be at an increased risk of brain tumors known as meningiomas. Patients may be able to file a lawsuit against Pfizer, for failing to warn them about the potential dangers associated with this medication.



Bard® PowerPort™

Bard PowerPorts — implantable ports that carry medicine into the bloodstream — can break apart within the body and cause serious harm to patients. Lawsuits against the manufacturer of these devices claim the company received multiple adverse event reports (AERs) that highlighted the dangers of their implantable ports, but failed to recall these devices or inform users of the risks.



Rideshare Assault

Across the country, brave individuals have filed lawsuits against Uber and other rideshare companies after being sexually assaulted or attacked by their drivers. We are committed to holding rideshare companies accountable for their negligence and fighting for justice on behalf of assault victims.
